2017 Past Due: If your membership OR your credential number started with WVTA 17-xxxx you are now PAST DUE. Please get your membership and credentialing update in ASAP or you will be dropped from the roster very soon. If you are not an active/paid member of WyVTA, your credential is invalid. We do receive requests quite frequently to verify CVT status from several states for job verification as well as for status in good standing!

2018 Renewals: Since we are fully in the biennial renewal status now, double check your expiry dates on your membership and your certification (if you are certified) to ensure that if you are an even numbered renewal (i.e. WVTA 18-yyyy) that your expiration is 31 December of this year. The Veterinary Nurse Initiative

What do you want to be called, a veterinary technician or a veterinary nurse? Some of you may be aware of the NAVTA effort to pursue legislative amendments in the 50 states to change the name

to Registered Veterinary Nurse. For those of you who aren’t familiar with this movement, this article is for you! At the recent Leadership Conference held by NAVTA at the AVMA Conference in January, this topic was covered in detail even though it’s been on the discussion circuit for several years. The Veterinary Nurse Initiative, or VNI, was officially coined in 2016 using the following concepts as listed on the NAVTA website:

- The goal of the initiative is to standardize the credential for our profession in terms of credentialing requirements, title, and scope of practice throughout the nation.
- A standard title should be used in all 50 states; in addition, a standard should be set in all 50 states for maintenance of credentials.
- A standardized credential will unify the profession and grow professional recognition.
- The veterinary consumer needs to understand what credentialed veterinary technicians/nurses do on a daily basis in regards to patient care
- Pet owners are demanding qualified veterinary nursing personnel, which leads to consumer protection and patient care

So what does this really mean to those of us working in the field?

First and foremost, the change will eventually implement title protection, allowing only qualified individuals to carry the credential. Next, if there is a national standard of credentialing, it will be easier to work in other states without having to transfer your credentials and/or fulfill additional requirements instituted by your new state of residence. Additionally, if there is clarity of the role of a veterinary technician/nurse, then it stands to reason that the public will better understand what we do and the qualifications we possess. This can ultimately elevate our profession and create a public demand for credentialed individuals to be involved in the care of pets.

It all sounds great, right? Well, to get to this point the first step is to create a single designation for all credentialed technicians – Registered Veterinary Nurse. Once this designation is established, each state will begin to align with standardized credentialing. In 2018, Ohio, Tennessee and Michigan will be introducing the initiative into legislature. National Credentialing and Title protection isn’t something that will happen quickly. Current estimate is it will take 5 to 10 years to implement in interested states. There is still a lot of discussion to be had, and even more work to do. You owe it to yourself to learn more about the VNI. Visit www.navta.net and click on the link “Veterinary Nurse Initiative.” From there you can read about all the aspects of the ‘movement’ and you can make your own decision how you feel about it. WyVTA Membership Meeting December 3, 2017

ADDENDUM: Email Board Vote: eVetSites website and domain change to pay annual website/domain fees by WyVTA check was motioned by Nanette Walker Smith, seconded by Cambria Harmon, and unanimously approved.

Details: Annual check paid in December to cover the following January through December calendar year (to eliminate monthly payment burden of our webmaster and reimbursement paperwork).

Accounting will be as follows:

\$49.00 (monthly charge) x 12 months = \$588.00

Annual (calendar year) domain charge = \$35.00

Total = \$588.00 + \$35.00 = \$623.00 payable by Dec 30 each year.

Tom Page: Welcome everyone. I call this meeting to order @ 8:07pm As everyone can see there are going to be some getting used to the new system and process. I have my update from the President post written in on the Agenda. Would every one please confirm that they can see it on the Zoom screen?

Tom Page: Aaron, can you give us a Treasurer Report?

Aaron: I got a fresh wave of membership checks and I revamped my reports a little just to make it easier on me. \$14,143.64 in the account starting the year. I'll have a complete January report at our February meeting, but so far in the first week \$690 in memberships and certifications rolled in this week. I do owe a 20 dollar reimbursement for over paid dues this year Only things I have left are 1 I need to buy a book of stamps and 2- we need to vote on the AAVSB check

Tom Page: We received the 2018 Bill for AAVSB. Last year we paid in June, July due to billing error.

Aaron: This is all this month but once the January report is done it will be and the "paper trail" is kept too

Marlane: Here are the topics I am looking at for the fall CE. Immunology and Principles of Vaccinations, and Cytology Focusing on Mass Cell tumors and different grades as well FNA's and what to look for. I am looking at the 2nd week of September for the meeting. I would like to discuss this with Wyoming State Vet Lab and CSU and see if we can get someone to speak on those subjects. Some of this will be large animal related as well.

Nanette: Are we staying at Parkway Plaza or going back to the old one?

Tom Page: We can discuss that and see if we can get a quote from both.

Marlane: I need to get some dates nailed down and see when I can get the speakers here. We may even look at the College, so that we might have use of the lab with microscopes.

Nanette: Did the evals give good input on dates? Might be nice for board to see results of evals. Give us a better idea of what happened/how it was perceived?

Tom Page: That sounds great. We will also have to shop around if we do the college to get a rate for rooms for travelers.

Marlane: I am planning on contacting Wyoming State Vet Lab to see if we can get someone from there to come speak. I will contact Parkway Plaza and see what they can do for rooms if everyone is happy with the rooms that they stayed in there. They have always seemed to give the best rates.

Tom Page: I have a trip to Colorado to a few hospitals next week. I will let you know if I hear anything. I will get you the name of the person we worked with last year.

Marlane: That would be great. As far as the evals from the conference, there weren't a lot of feedback, just some suggestions that we cover more large animal stuff and that we do some general information about vaccines.

Tom Page: The website is down. I will be following up on this tomorrow.

Deana: I have been getting membership renewals and new certifications. I have ten more going out tomorrow. Two of them are new. So far I have credentialed six new people this year!

Cambria: That is great news.

Tom Page: We will be receiving a travel grant from VCA for some of our expenses to the NAVTA meeting.

Nanette: I need the VCA logo or whoever it is we are supposed to thank for the grant. I do not have it in my email.

I'd like to see Tom and Roxane write up information on what they learned from the leadership conference over the next month or two so we can use those in the newsletter.

I have Aaron's Nov and Dec Treasurer reports to final out the year for the newsletter. Looks like all the sponsor checks came in from the sponsors/vendors.
