I hope everyone has a great summer and enjoys the beautiful weather! See you all in September!

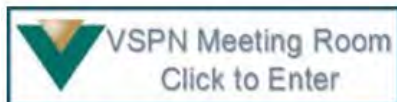

MINUTES

WyVTA Meeting May 1, 2016

Lori Power: Kati texted me and said she won't be able to make it. I'm happy to run the meeting. I'd like to call the meeting to order. Let's do the Treasurer's Report before we go any further.

Karen Schutt: Starting balance: \$14,888.05, one check to Jackie for the website (\$49.00), balance of \$14,839.05. I did not realize that we had gotten a check from Zoetis until Kati sent me the receipt. Kati didn't deposit it until January 20th of this year. So the actual balance is \$15,839.05.

Nanette Walker Smith: Cool. Is that the check for THIS year's CE, or last year?

Carol Larson: We never got one for last year's CE. We were supposed to, but never got it. I had submitted an invoice to Lynn for last year, but no check.

Karen Schutt: It has an invoice date of 8/21/15.

Lori Power: I haven't finalized any sponsorship for this year's CE. So if they did get one from Zoetis for this year, I wasn't privy to it.

Melanie Beardsley: **I move we approve the treasurer's report as stated above.**

Cambria Harmon: **I second.**

Lori Power: **All voted in favor: Motion passes unanimously.**

Nanette Walker Smith: Karen, have you had a chance to do our e file for the IRS yet?

Wyoming Secretary of State will be a card that comes in the mail probably in September/October. The anniversary of when we re-upped; and we have to update it with our new officers each year anyway.

IRS is federal only; needs to be done by May 15 each year. We should set up a time to go through this together. You'll need to set up a new login for the treasurer.

Lori Power: It appears that Tessa has to relinquish her position as secretary.

Nanette Walker Smith: She's been offered a full time position at the equine practice and has accepted! Tessa has the membership and certifications under control and will have them ready to pass on. What IS outstanding is following up on an invoicing system to present to the board (which was to be me and Tessa) and the discussion here in the board as to how we would want to (if we want to) approach the membership about going to biannual membership/certification at the fall annual meeting.

Thus, first order is finding a replacement ASAP so I can work with that person on the invoicing issue in between meetings.

Meantime, board needs to discuss logistics of how to proceed (if it wishes) with biannual membership/certification so we have it ready to present in writing at least 30 days prior to the fall CE. In the form of an amendment, that is.

Lori Power: I don't have much of a fall CE update. I have got a contract with the Ramkota for September 10th. Spoke with Dr. Thamm and have a list of everything they need for their presentation.

Nanette Walker Smith: Cool. Will we be able to get a flyer ready for the June newsletter? (i.e. by June 1st) including pricing for the conference and rooms? We should vote on price for the conference tonight in order to do that! Last year was for the full 8-5, including luncheon meeting: \$70.00 member/early bird by 9/1, and \$90.00 for non-members.

Melanie Beardsley: We would want to move the early bird date up. Last year's meeting was the 19th.

Nanette Walker Smith: Good point, Mel. This year we only have 6 hours of CE. Do we want that to affect the price? Need to look at cost of last year for speakers vs. this year for 4 speakers plus their rooms.

Lori Power: Speakers are \$150.00 per hour this year. And there will need to be 4 rooms. They still have us set in the Teton room, but Mel said there were a lot of complaints about noise last year; so I might see what else they can do. Total for room and equipment for the day is \$105.00 on this proposed contract.

Nanette Walker Smith: I would recommend postmarked by Friday, August 19 (or earlier) - that's a bit over 3 weeks. How does price compare to last year for the behavior doctors, Mel and Carol?

Melanie Beardsley: I think it's a little less. It would be about \$900.00 for this year's speakers. Last year was \$1,200.00 or \$1,300.00.

Carol Larson: It will be in the checkbook and there are invoices in the file. We only had 2 speakers last year and they were husband and wife; so only one room.

Nanette Walker Smith: Do we have a block of rooms again this year, Lori? What are the prices?

Lori Power: I am waiting for a return email from the hotel with that information.

Nanette Walker Smith: OK, so we are probably looking at the same price for speakers since we will need 2 or 3 rooms. But the speaker cost is lower. Mileage will be slightly less, since they are only coming from CSU not Denver. After early bird deadline, the price went up to \$100.00 regardless of membership. That said, do you think we can ask for the same price, even though we have only 6 hours of CE?

Melanie Beardsley: I don't see why not. (I think last year was 7 hours of speaker time.) It is still over half of what we require every 2 years.

Cambria Harmon: Wouldn't it come down to ensuring that the costs are covered by attendance, right?

Lori Power: This is mildly off topic, but I have had some veterinarians express interest in going. Do they pay the same fee?

Melanie Beardsley: It's still pretty inexpensive CE. Yes, Lori. (And they are encouraged to come!)

Cambria Harmon: I don't see why we should lower the cost, because it seems really affordable compared to stuff here in Washington.

Carol Larson: It is inexpensive. And with the Zoetis and any other donations, we have come out ok in the past. Even if it costs the organization a little, CE is a big purpose of the organization. I say leave the price the same.

Nanette Walker Smith: Normally vets pay more, but we have never charged more for vets that I recall?

Melanie Beardsley: We didn't last year. I say we leave the price the same, too.

Carol Larson: There was one vet last year.

Karen Schutt: It is a reasonable price for a full day. I say leave it the same, especially if we think the expenses might be a bit less.

Nanette Walker Smith: No difference for vets. And I would say they are welcome. This is an excellent TEAM topic (plus it includes price for lunch). **I motion that Fall CE 2016 pricing be as follows: \$70.00 for members, \$90.00 nonmembers for early bird rate by Friday, August 19, 2016 (postmarked by).**

Lori Power: I second the motion.

Lori Power: All voted in favor; Motion passes - was unanimous.

Melanie Beardsley: I was going to mention when we get to making the flyer that we put the whole team, including doctors are welcome. Also, we need to put how many hours of CE on the flyer. (Had questions on both last year.)

Nanette Walker Smith: Postmarked after August 19th through onsite registration is \$100.00. Pricing is good for any veterinary staff member.

Cambria Harmon: And with having CE every year now, it still covers the hours required every two years if you attend.

Nanette Walker Smith: Lori will need to confirm 6 hours (Dr. Thamm's second lecture did not have 1 hour with it).

Lori Power: Ok.

Nanette Walker Smith: We should double check with WyVMA regarding approval for veterinarians attending to make sure veterinarians can use that CE for their required CE.

Melanie Beardsley: I tried to get in contact with them last year about even putting information in their newsletter about our CE day. They never got back to me. It would be nice if they would mention our CE day in their newsletter, if we get in contact with someone.

Nanette Walker Smith: We don't submit to RACE (AAVSB - too costly) :) Mel - that is Vicki Smith - their ex director. I can assist with that. *Cambria Harmon:* Scholarship applications: They can still apply through the end of June. Scholarship applications went out in the newsletter. Those applications go to the committee for review and August's meeting we will vote on the winner.

Nanette Walker Smith: Amanda - pump up your students for scholarship application submissions.

Amanda Johnson: Will do.

Nanette Walker Smith: I believe the online CE option Kati was talking about 2 months ago as a feature is an option; however, the speakers listed were mostly outside the US. Many of them will not be approved for other states - not that this is an issue for our regulations; however, a lot of what they will lecture on will not be either available or useful in the US (medications, dosages, approved protocols, etc.) Always good to learn new stuff and USUALLY these folks will present across the borders, but not always. NAVTA recently launched a similar online CE feature through their website that does not require any monetary buy in from us and it is available to all NAVTA members. When NAVTA sent theirs, I thought it looked SO familiar, so I pulled them up side by side and sure enough - it is a stripped down version of the World group. Removing those folks that have not lectured in the US or whose topics are not North America based. A bit more refined than everything under the sun.

Melanie Beardsley: Might be better to go that route if someone wants to then.

Nanette Walker Smith: My understanding is we need to have an answer for them regarding advertisement. And personally, for the 100 VTs we have on our roster for Wyoming and the surrounding area, I don't feel comfy signing contracts that may or may not be beneficial to our members. We can't even get them to get online with VSPN, which has awesome CE, or come to our online meetings :)

Melanie Beardsley: I agree, Nanette. I don't see our members taking advantage of it.

Lori Power: Motion to adjourn.

Melanie Beardsley: Second.

Lori Power: All approved; Motion passes. Next meeting June 5.

Karen Schutt: Yes. Nothing new since our last meeting. Checking balance is \$15,890.05.

Carol Larson: Karen - I got an email from Bank of the West regarding online access and the bank statement notices. You will need to call or go in and get that re-set up with your email.

Karen Schutt: I just tried tonight. I talked to them two weeks ago. I am frustrated. I will call tomorrow; thank you.

I completed our 2015 e-filing for our IRS tax papers.

Kati Martin: That is outstanding to know it is done!! Thank you Karen and Nanette!!

Melanie Beardsley: I haven't heard back on recommendations from NAVTA regarding certification of persons with a criminal history. I did e-mail them last week.

Kati Martin: And I contacted the secretary of state, but never got any word back from them. It may be of no concern to the Secretary of State because we are not recognized in the practice act or in any legality other than our tax filing.

Deana Baker: If we were recognized, then the rules would be different.

Melanie Beardsley: I did want to bring to everyone that NAVTA is having a leadership workshop August 5 in San Antonio, if anyone is interested in going. 4 hours of RACE approved CE is \$75.00 and Merial is covering lunch. It is being held in conjunction with another AVMA meeting, I believe.

Kati Martin: Excellent! Maybe something worth looking into if someone would like to go.

Melanie Beardsley: Did you feel you and Lori learned and networked enough to make your trip worthwhile at the last one?

Kati Martin: I think we did learn quite a bit; just wonder about a 1 day'er.

Melanie Beardsley: Yeah, I think it would be better to hold out for the big meeting if we are going to send anyone.

Kati Martin: I would agree. Does anyone have anything more about the membership fees and increasing to new members and/or the background check topic?

Tom Page: Sorry I missed the last meeting. Would you mind restating comment on fees and increasing to new members?

Melanie Beardsley: Frankly, I think running them is going to be a huge deal for us. Not to mention the logistics and cost of it all!

Deana Baker: I am still on the fence about background checks. We would have to have some standards set up as to what we would and would not allow. Since we are not a state entity, this could cause us some problems. If we were recognized by the state, then we would have some backing.

Kati Martin: Yes, but we can eventually get there if we start to have issues with it more frequently.

Have any of you heard if our new Secretary, Karen Bryant, is ready to step in yet? She contacted me after the last meeting and I am waiting to hear if she has heard from Tessa at all. I will contact Tessa and find out what is going on in the meantime.

Deana Baker: Tessa will be starting her new job tomorrow.

Kati Martin: Thank you! Is there any other news we need to cover tonight?

Melanie Beardsley: Anything about scholarships

Tom Page: I am wondering also.

Kati Martin: I honestly don't know; haven't heard anything from anyone on them. I will get a note out on Facebook about them and hope that the school girls/boys will see it.

Melanie Beardsley: OK, well they have a little more time to get stuff to us. Deadline is the end of this month, right? Website looks like the old application form is on it and it is to be mailed to Jackie.

Kati Martin: Yep, sure is. I will get an email to her also about getting that changed.

Melanie Beardsley: On that note, I motion we adjourn.

Deana Baker: Second.

Kati Martin: Unanimous approval; Meeting adjourned.

Award: One \$500 scholarship awarded annually to one Wyoming resident.

The purpose of this scholarship is to aid Wyoming residents in obtaining a degree in Veterinary Technology.

Minimum Requirements and Limitations:

- Students must have completed at least 2 (two) semesters, or semester equivalents, at an AVMA accredited veterinary technology program and be enrolled in the next semester.
- The scholarship is limited to current Wyoming residents only, but the accredited program may be distance education or on site as long as it is an AVMA accredited institution of veterinary technology.
- Individuals may apply annually as long as eligible, but may only be awarded the scholarship one time.

Requirements to be submitted at the time of application:

1. Proof of Wyoming residency (copy of Wyoming driver's license, etc.)
 2. Proof of current enrollment in an accredited AVMA program (receipt from registrar or program director letter)
 3. Official transcript sent directly from the school to address above showing successful completion of at least two (2) semesters, or semester equivalents, of the program
 4. Two letters of recommendation; at least one from a person within the veterinary profession such as veterinary employer, supervisor, or teacher (DVM or CVT)
 5. Typed essay explaining personal and professional goals and need for scholarship (500 words maximum)
 6. Signed and dated Cover Sheet & Form of Understanding for completion of the semester of scholarship award
- PLEASE NOTE:* If the student is awarded the scholarship, the student must provide proof of completion of the fall semester or semester equivalent via transcript copy as soon as completed. Failure to complete or provide the transcript will require the student to reimburse the WyVTA for the awarded monies immediately.

Submission instructions:

- **Complete Typed Application Packet submissions are DUE by June 30th** of the year the student is applying for the scholarship.
- **All items* should be in ONE envelope mailed to the association at PO BOX 34, Cody, WY 82414.**
- ***The school transcript should be sent directly to the WyVTA via mail.**

Scholarship Award Information:

- Notification will be via certified mail/telephone call by August 15th.
- Monies will be awarded via check which will be post marked no later than August 20th to the student's address listed on the application.
- Student is encouraged to attend the Wyoming Veterinary Technician Continuing Education Meeting traditionally held annually in September and accept the award certificate in person. *The WyVTA will sponsor the recipient's meal and registration fees.*
- WyVTA will extend one (1) Student Level Membership to the scholarship recipient starting from the award date valid through December of the following year.
- The student will be asked to provide a photograph or be photographed for the WyVTA to feature on the website and used in public announcements such as in the NAVTA Journal.
- *The WyVTA Executive Board and Membership strongly recommended that scholarship monies be used for books, laboratory fees, and/or to assist with tuition.*
