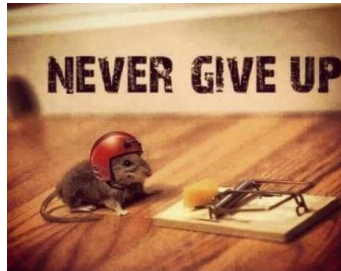

## DO YOU LIKE FREE MONEY?? Apply for the WyVTA Student Scholarship!!

### Minimum Requirements and Limitations **DUE BY April 30:**

- Students must have completed at least 2 (two) semesters, or semester equivalents, at an AVMA accredited veterinary technology program and be enrolled in the next semester.
- The scholarship is limited to current Wyoming residents only, but the accredited program may be distance education or on site as long as it is an AVMA accredited institution of veterinary technology.
- Individuals may apply annually as long as eligible but may only be awarded the scholarship one time.

and Regulations but will not affect the VPA at this point. Our brochure is key to educate Wyoming DVMs at the June Meeting so they understand what we are striving to accomplish and what we offer.

*Kelly Ferguson:* We're having a meeting tomorrow evening, yes? And there has been talk about changing CVT's in the Rules and Regulations with the EB of the WVMA which is not a super easy thing, but it wouldn't be in the practice act.

*Nanette Walker Smith:* Hot topic at AVMA. Wyoming agreed that was out of our scope of attention right now - we have bigger fish to fry just to get the DVMs on board. This is why that brochure and education of the DVMs is going to be a key focus for the WVMA conference in June.

*Kelly Ferguson:* They're having a sort of "focus group" meeting in Cheyenne. If that goes well, they'll likely have other "focus group" meetings in other parts of the state as well. The subject under discussion for tomorrow night will be that focus group meeting.

*Nanette Walker Smith:* Yes next meeting is Monday, March 6 via Zoom.

*Kelly Ferguson:* What they'd ideally like to do is get something in Rules and Regs now for CVT's, and then hopefully make some much needed changes to the VPA of Wyoming, and completely re-vamp the entire thing at a later date.

*Nanette Walker Smith:* The legislature may recommend the VPA sunset and go ahead and put in regs to the VMB now and then we can be regulated by the state, and in the next couple of years work on getting VTs into the VPA as well as multiple other changes that need to be updated over the last 10+ years. There are more hearing about it which is good, emailing the association so for tomorrow we need to discuss having some FAQs to point to by the committee for answers so we aren't disseminating different information.

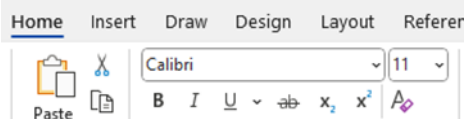
