Absent: none. Tom reported and left early due to illness. Kelly reported and left early due to being on call.

**Taeha Collins called the meeting to order at 7:09pm.**

*Melanie Beardsley:* I read through the January minutes. I motion we approve the Jan 2023 minutes as they were e-mailed out last month.

*Nanette Walker Smith:* 2nd

*Taeha Collins:* Motion passed to approve January minutes

**Treasurer: Kelly Ferguson, CVT:**

1) September treasury CE report still in progress. Tom, Jackie B. and are on this, however, I still do not have access to the bank account (i.e. online banking).

2) Bank of the West told me that I have everything submitted that I need, but that others do not. I'm able to make deposits but nothing else.

**Membership: Jackie Van Noy and Beth Zima:**

1) All of the membership stuff has been transferred to Beth

*Taeha Collins:* Beth did you receive the email I forwarded to you re recertification?

*Elizabeth Zima:* Yes, I did and I have been responding to those as they come in.

*Nanette Walker Smith:* Beth - you actually have several membership/certification emails in there for you. THANK YOU in advance.

*Elizabeth Zima:* Yes, I have 16 apps I'm working on!

**NAVTA Representative: Hannah Haman:**

1) NAVTA has Dental CE for free on their website for the month of February.

2) Last month NAVTA released a statement on their stance on mid-level practitioners which at this time remains to be that they would like to continue advocating for full technician utilization and for title protection and are not currently supporting mid-level practitioners at this time.

**Media Committee: Kelly Ferguson, Taeha Collins, and Beth Zima**

*Nanette Walker Smith:* The way you view FB has been constantly changing the last couple of years.

*Elizabeth Zima:* My daughter said that our FB is NOT set up right now as a non-profit. She's going to help me change that for us!

*Nanette Walker Smith:* Somehow, our page is acting as if it's a profitable business and that's why our job posts have been all wonky lately. I just posted one for a Littleton Mixed Animal Practice. That's when I noticed the job posts are ending totally on 2/22/23 So that's the 2nd thing we need to figure out how we will offer that up to our members other than our newsletter.

*Melanie Beardsley:* Could we just post them on the website and make a comment on our FB page when we have a new job posting on the website?

*Nanette Walker Smith:* Good thought Mel - I'm not sure if the new way will allow that or not - we used to just post it as a thread. Now if you post a job, it grabs that word and forces a form fill out which then looks like WyVTA is doing the hiring. I can SORT OF get it to show the city/state of who's hiring but it really is difficult to tell.

*Elizabeth Zima:* We could start with that and then get the FB issue fixed. We should be able to on FB as a nonprofit. I'll work on the FB end.

*Nanette Walker Smith:* Job posts should go through Secretary - there is a file in the Secretary's files for job posts so we can go back to them - it's been flimsy at best. Because they come and go.

**Secretary: Nanette Walker Smith and Jackie Breed:**

1) Please submit items in WORD format in Calibri Font 11. That allows us the fastest change over. It's the default font and size for word docs.

2) I believe everyone is caught up with 'switch over' of position stuff except secretary and I now. Correct?

*Nanette Walker Smith:* Other than the last little bank things for Treasurer Jackie B - you guys are all switched?

*Jackie Breed:* Yes, Kelly has all of the Treasurer items.

3) *Nanette Walker Smith:* I'm still getting pings about the simple form 990 submissions I have not seen the copy of verification that was submitted come into the secretary's email box for safekeeping so - I'm a little concerned. This is that little tiny document we have to file for the IRS that maintains our non profit standing for income, donations, not exceeding \$xxxx. If it doesn't get filed we LOSE our non profit status and we go through the 2.5 years of hell that brought be back on board to get us back on track with the IRS. It's the 990-n via the IRS.gov

*Jackie Breed:* I passed that task onto Kelly when I passed her the Treasurer items a few weeks ago. I know she is still struggling with the Bank of the West login, so I'm not sure if that is the holdup on it. I had talked her through how to do it and where to find the info.

*Melanie Beardsley:* Jackie B, can you follow up with her and make sure she got it done?

*Jackie Breed:* Yes, I will follow up with her.

*Nanette Walker Smith:* Thanks Mel - yes that is correct (\*NEVER EVER AGAIN) you can default on it 3 times, but you don't want to esp. now we actually have income and it looks a little weird for a non profit to have income with no out go and suddenly not be filing.

4) *Nanette Walker Smith:* Did we get the new eVetSites bill yet? Treasurer gets the bill and President is CC'd as a catch.

*Taaha Collins:* I have received emails from them-Didn't know what to do with them so they are in my in box yet..

*Nanette Walker Smith:* Treasurer had sent a check and then they'd said they would send it back and send out a new invoice.

*Jackie Breed:* Yes, the bill was in the Treasurer e-mail before the January meeting. We had discussed the bill as there was a question regarding Dr. Bell as the Veterinarian still on the bill. That was also on Kelly's to do list.

5) *Nanette Walker Smith:* Jackie follow up with Kelly on eVetsites as well, please.

6) *Nanette Walker Smith:* We do not have a CE report - I will talk to Tom about that. We have the September bank report which matches the bank - right Jackie B.? as far as ins and outs.

7) *Taaha Collins:* ok-EWC? Any luck?

*Melanie Beardsley:* Jackie B, did you and Kelly talk about/send an invoice to EWC?

*Nanette Walker Smith:* Nothing from EWC in either of my boxes. Membership needs to send out the letter - Jackie VN..... did you do that before you switched over?

*Jackie Breed:* Kelly was going to work with Tom on who and how to contact EWC. I have not heard any more in that regards.

*Jackie Van Noy:* I didn't

*Jackie Breed:* I had sent out the letter last year, 2022, after collaborating with Jackie V. I never received any type of response from that letter.

*Nanette Walker Smith:* It's supposed to be Dr. Colleen Mitchell the Program Director.

*Jackie Breed:* That is where I had sent the letter and multiple emails.

*Nanette Walker Smith:* As I've said before I'm wondering if it accidentally got circular filed it or she sent it ahead to their financial dept who said - it's not budgeted and just turfed it. I'm wondering if it's not time to go to the Dean or schedule a meeting with Dr. Mitchell and the Dean.

*Taaha Collins:* I agree the Dean needs contacted. Is that a Secretary deal?

*Melanie Beardsley:* Probably Membership since they will be the one sending the letter/invoice, Taaha.

*Taaha Collins:* Can we add a beginning note as opposed to just an invoice? Maybe we need to add a statement regarding what Nanette just said.

*Nanette Walker Smith:* Yes we do need to do a letter - needs to include something about the upcoming review of legislation for credentialing of veterinary technicians in Wyoming, how that may help their application and enrollment numbers to the school and help keep those students in Wyoming.

*Nanette Walker Smith:* If someone wants to pen that cover letter and send it to me for input - I'm more than happy to do that before that goes with the invoice.

*Taaha Collins:* K-On it

**Past President: Melanie Beardsley:**

1) I'm planning on laying the hammer down on the scholarship stuff. I have no updates there.

*Nanette Walker Smith:* Did you see the updated scholarship form I sent to the committee? It was the one Tom and I went over with for changes right after Fall CE. I at least made those edits so the committee could review them now. Tom will have the most - I think he had thoughts of other things to discuss with a group. I would probably get him to commit to a zoom meeting or something soon so we can get on this. It needs to be out ASAP - it has a new due date and new stipulations which is a big change.

*Melanie Beardsley:* I skimmed through it but didn't have the brain power to really go over it.

*Taaha Collins:* Same-but I didn't have any issues.

*Melanie Beardsley:* I'll get through it and get it organized and everyone's thoughts on it ASAP.

2) I still need to order stickers, shirts, and coats. I think Beth had sent an e-mail to the President position. Taaha, could you forward that to me? Also, I need jacket orders from you and Kelly to move forward with that. I thought I had the list of shirt sizes/colors that were sold at the conference so I can order to replenish them. I couldn't find it anywhere in the e-mails/computer before I gave it to you, Taaha. Tom doesn't think he has that list, either, when I asked him. He had sizes, but not colors. Nanette, do you happen to have it?

*Taaha Collins:* I am still looking for a jacket. I do have Beth's order and will forward tonight.

*Nanette Walker Smith:* I had a list of sizes and colors and y'all said you had it all down, so I verified it and chucked it. I'll see what I have.

*Jackie Breed:* Can you find the sizes and colors sold on Square?

*Melanie Beardsley:* I don't know that colors where on there, Jackie. And some folks paid cash, I'm pretty sure.

*Nanette Walker Smith:* I don't think the colors were - sizes were but they were grouped.

**Scholarship Committee: Melanie Beardsley, Cambria Harmon, Taaha Collins:**

- 1) Cambria e-mailed back that she is on board to stay on the committee. Taeha, I think you have to "appoint" her. (Basically state that she is interested and you want her to remain on the committee.)

**Taeha Collins:** As 2023 President of the WyVTA, I am re-appointing Cambria Harmon to the Scholarship Committee as a non-board member to assist with the committee details and selection process.

**Legislative Committee: Nanette Walker Smith, Tom Page, Jackie VanNoy, Deana Baker, Kelly Ferguson:**

**Nanette Walker Smith:** Meeting in January was interesting - the mid level practitioner took a lot of discussion because it was fresh from AVMA conference that Dr. Healey went to. As a group we all decided it was a potentially nice idea, but Wyoming is way behind as far as being in a position to consider that as we have multitudes of DVMs right now that are against VT's being credentialed. We are adding back into our definitions for supervision the term immediate. This will go with direct and indirect.

**Taeha Collins:** YUP-Mainly due to misconception-It was awesome we had all spectrums-I didn't expect to speak but we had a full spectrum of a tech that went right into school-one that was working and did online and myself who passed VTNE without school-It worked out great

**Nanette Walker Smith:** We have a meeting tomorrow night, and the agenda is already long. At this point we are still whittling. The DVMs realized they were not prepared at the WVMA meeting for the other side and answers. I told them, selective hearing. So now we are on to how we can better educate the DVMs (and public - selective hearing again) about educated staff.

**Taeha Collins:** I would suggest that we send the supervised/unsupervised list be sent to all WY vets for suggestions (with a deadline) The only things I had from my doc was Rabies vaccines and ultrasounds on equine.

**Nanette Walker Smith:** Still on for q 2wks Monday evenings at this point. They are leaning toward title protection but that has to come with education of terms. We are working on potentially a survey - to get to all veterinarians and veterinary staff. Not sure if it will be the same or 2 separate. But the difficulty will be getting out to ALL licensed veterinarians for their input.

**Webmaster: Nanette Walker Smith:**

- 1) Ok web admin we have not already discussed. I'm still on Tom's bio, Jackie B's is done.
- 2) Other items: Previously tabled
  - a) Do we want to charge for a reprinted CE certificate?
  - b) Do we want to charge for a letter to whomever stating CE was completed for a person for x time/x hours (rather than a reprinted CE certificate for our Ce or stated person reporting completing CE?)
  - c) Do we want to charge for a reprint of membership+/- certification cards(suggested \$5 a piece, includes postage)-Point is.. Important to keep track of your CVT credential so that \$10 is essentially would be recertification again.
  - d) Above may be a mute point if/when licensure is taken over by the state. However, VMA is seeing this change to LVT taking 2 years at least.

**Nanette Walker Smith:** The other hangers on there (2 a-d,) I recommend we still table - these are so rare and I feel like Beth needs to get her membership feet wet before we decide further. Jackie VN needs to pipe in on these too at some point. Or we can dump. Definitely do not need to address at this point IMHO

**Taeha Collins:** As long as we don't have a huge influx of people needing copies-if it becomes an issue we can revisit- Beth can you please keep us in the know?

**Elizabeth Zima:** Will do!

**Elizabeth Zima:** If I have determined that 3 people paid for dues this year but were not due or paid twice, do I refund them in Square?

**Melanie Beardsley:** We typically do the refunds as a check, so we are not paying square fees twice.

**Nanette Walker Smith:** Refunds are not done on Square, fees are charged if they paid by credit card. The \$2.50 fee is not returned to them.

**Elizabeth Zima:** I will send a list to the treasurer, Kelly.

**Jackie Van Noy:** The folks that paid by check were easy. I kept their ce record on file but returned or tore up the check.

**Melanie Beardsley:** And she will have to put it on her list for the agenda so we can vote on it correct, Nanette?

**Nanette Walker Smith:** Vote on reimbursements. No actually shouldn't need to. Not if they paid incorrectly - They do need to be in the Treasurer's report and that can be explained. It's just like if there was a bill that was incorrect. As long it was tracked. We just have to redact the names out of the minutes that are printed in the newsletter so Treasurer would say for example, we had 3 people pay membership/certs too early so they were refunded; one was a check for full payment of \$40 for membership and certification on time, 2 were for membership and certification charged on time without returning the 2.50 square fee for \$50.00

**Taeha Collins:**

- 1) New business: The only remaining issue I have and I may be wrong but are the July and August dates for meetings on a Monday?

**Nanette Walker Smith:** august 6++ and august 27 (board only), July 9th

**Melanie Beardsley:** If there isn't, I motion we adjourn.

**Elizabeth Zima:** 2<sup>nd</sup>

**Taeha Collins:** Motion passes to adjourn at 9:36pm-Thank you all!!
